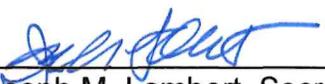

1. Applicant: City of Placentia

Project Location: Atwood Multipurpose Trail Project adjacent to the Atwood Channel approximately 600 feet east of Jefferson Street to Lakeview Avenue

Mitigated Negative Declaration No. 2023-01 (Atwood Multipurpose Trail Project): The City of Placentia, in cooperation with Orange County Flood Control District and the California Department of Transportation, is proposing to construct the Atwood Multipurpose Trail to increase the number of pedestrians and bicyclists using public transportation. The proposed trail would be a 1.0-mile-long trail along the Atwood Channel starting from the BNSF/Metrolink railroad tracks, approximately 600 feet from Jefferson Street to Lakeview Avenue.

Recommended Actions: It is recommended that the Planning Commission take the following actions:

1. Receive the staff report concerning Mitigated Negative Declaration (MND) No. 2023-01; and
2. Adopt Resolution No. PC-2023-14, a Resolution of the Planning Commission of the City of Placentia approving the adoption of MND 2023-01 for construction of the Atwood Multipurpose Trail Project adjacent to the Atwood Channel approximately 600 feet east of Jefferson Street to Lakeview Avenue, and finding that the Mitigated Negative Declaration, adopted with respect to the project was prepared in compliance with the California Environmental Quality Act (“CEQA”), California Public Resources Code § 21000, et seq., the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, §§ 15000, et seq., and the Environmental Guidelines of the City of Placentia; and
3. Direct staff to file a Notice of Determination (NOD).

Director of Development Services, Joe Lambert, presented the staff report and provided a brief project introduction and of the CEQA Determination for Mitigated Negative Declaration No. 2023-01 (Atwood Multipurpose Trail Project). Documents provided to Commissioners included four mitigation measures, relating to hazards and hazardous materials, noise, and cultural (tribal) considerations.

Transportation Manager Kyra Tao then provided additional information about the trail, including its location, opportunities to bike and walk for residents, and the overall mobility goal of expanding the active transportation network. Transportation Manager Kao presented a map and photos of the existing and future trail and explained the future

connectivity over the railroad track. She also highlighted a resident survey about the project and the feedback received. She noted a potential future-planned bridge or tunnel to cross the railroad tracks east of Jefferson Street.

Discussion ensued regarding the existing oil pump adjacent to the trail, workflow as relating to tribal issues, train crossing considerations, potentially closing off the trail at a certain point as well as the responsibility of ongoing maintenance of the trail.

Project Location: 1251 E. Yorba Linda Blvd.

Use Permit (UP) 2023-06

To allow the establishment and operation of a veterinary hospital at an existing, 3,000-square-foot commercial space located within a multi-tenant commercial shopping center at 1251 E. Yorba Linda Blvd, in the Neighborhood Commercial Zoning District; and making findings that the project is categorically exempt pursuant to the California Environmental Quality Act (CEQA) set forth in Title 14 CCR § 15301 (Class 1 – Existing Facilities) and the City of Placentia environmental guidelines.

Recommended Actions: It is recommended that the Planning Commission take the following actions:

1. Open the public hearing concerning Use Permit No. UP 2023-06; and
2. Receive the staff report and consider all public testimony; and
3. Close the public hearing; and
4. Adopt Resolution PC 2023-12, a resolution of the Planning Commission of the City of Placentia approving Use Permit No. 2023-06 and making findings to permit UP 2023-06 allowing the establishment and operation of an veterinary hospital at an existing, 3,000-square-foot commercial space located within a multi-tenant

commercial shopping center at 1251 E. Yorba Linda Blvd, in the Neighborhood Commercial Zoning District; and making findings that the project is categorically exempt pursuant to the California Environmental Quality Act (CEQA) set forth in Title 14 CCR § 15301 (Class 1 – Existing Facilities) and the City of Placentia environmental guidelines.

Planning Technician Devan Wells presented the staff report and provided a brief overview of proposed Use Permit No. UP 2023-06, including the site map, floor plan, hours of operation, staffing, parking, as well as details about the proposed use of the space and site conditions.

The Applicant, Dr. Allison Yasso and several of her staff members were present during the meeting. Dr. Yasso answered several questions from Commissioners.

Discussion ensued regarding how many animals would occupy the space daily, surgeries performed, length of stay of animals, emergency action plans, as well as clean-up of animal relief areas. The applicant agreed to comply with all conditions of approval. Commissioners also discussed the line of site analysis on three of the driveways and it was noted by Transportation Manager Tao that the City of Yorba Linda would be contacted to further discuss line of site concerns as that portion of right-of-way is in Yorba Linda.

Chair Perez closed the public hearing.

RECOMMENDATION:

It is recommended that the Planning Commission take the following actions:

1. Open the public hearing concerning Use Permit No. UP 2023-09; and
2. Receive the staff report and consider all public testimony; and

4. Adopt Resolution PC-2023-15, a resolution of the Planning Commission of the City of Placentia, approving UP 2023-09 and making findings to permit the establishment and operation of a 1,078-square foot dance studio by expanding the business operations of the applicant's primary dance company into a separate commercial unit, within the same multitenant shopping center, located within the Neighborhood Commercial (C-1) Zoning District, at 1864 N. Placentia Avenue.; and making findings that the project is categorically exempt pursuant to the California Environmental Quality Act (CEQA) set forth in Title 14 CCR § 15301 (Class 1 – Existing Facilities) and the City of Placentia Environmental Guidelines.

REQUEST:

The applicant, Lisa Silva, dba The Art of Dance & Ballet Academy, is requesting a Use Permit for a 1,078-square foot dance studio located within an existing one-story, multi-tenant commercial retail center at the Sierra Vista Plaza Retail Center at 1864 N. Placentia Avenue, within the C-1 (Neighborhood Commercial) Zoning District. The proposed dance studio will be an expansion of the business operations of the applicant's primary dance studio, which is located in the same shopping center, at 1840 N. Placentia Avenue.

PROJECT BACKGROUND AND DESCRIPTION:

The applicant has an existing dance school which is occupying a nearly 10,000-square foot tenant space for over a year, within the Sierra Vista Plaza Shopping Center. The applicant is now wishing to expand on the business operations, by occupying a 1,078-square foot tenant space, located within the same shopping center. The space will be utilized for specialized instruction and private one-on-one lessons, but will operate collaboratively with the existing business. The subject

property is located within the recently remodeled Sierra Vista Plaza, which is a one-story, multi-tenant, commercial retail center located in the southeast corner of W. Bastanchury Road and N. Placentia Avenue, within the C-1 Zoning District. A variety of commercial uses occupy the retail center including Grocery Outlet, Crunch Fitness, Art of Dance & Ballet Academy (main site) and other related retail uses. The subject location for the new space is located behind and adjacent to B & C Burgers. The primary location of the dance school is located in the southeast corner of the shopping center. The proposed space will be located on the easterly side, towards the rear of the shopping center. While the proposed tenant space is not adjacent to the primary dance school, a pedestrian walkway connects the two spaces.

The shopping center is presently accessible from multiple driveways on the west (N. Placentia Ave) and north (W. Bastanchury) ends of the property. There is another driveway and extra parking along the south and east edges of the property, in addition to the main parking lot. Sierra Vista Plaza, where the proposed site is located, is a neighborhood commercial shopping center that is surrounded to the East, West, North, and South by single-family residential.

The Art of Dance & Ballet Academy has had a long-time presence in the community of Placentia. The women-owned and run business has been operating in Placentia for nearly fourteen years, with the last year being at their new location in Sierra Vista Plaza. The dance company participates in the Heritage Festival and Placentia Tree Lighting Ceremony. The studio also offers classes in the City of Placentia Community Guide and works closely with Placentia Yorba Linda Unified School District dance teams. The dance school is so successful that they wish to offer their students more private lessons, so they can assist them in advancing in their craft. The vacant 1,078-square foot tenant space, located a short distance from their business, is a good opportunity for the business to expand their operations, and offer private lessons, without needing to consume a large amount of floor area for dancefloors, which are primarily used for larger classes.

The 1,078-square foot dance studio proposes operating hours similar to the primary dance school. This space, while much smaller, will have 1 dance teacher and 1-3 students for private instruction. The location will have a small reception area and restroom.

The business proposes the following operating hours, which staff has slightly extended to allow flexibility:

The proposed floor plan features one large dance floor, with an ADA compliant bathroom for a total floor area of 1,078 square feet. The applicant plans to add a small reception area. The tenant space is currently undergoing light remodeling and there will be no changes to existing onsite access or parking as a part of the request. All operations will be fully conducted indoors.

Applicable Code Section – Placentia Municipal Code (PMC)

The “C-1” district is intended to provide for general retail and office uses which offer the sale of goods and services to the general public and which, through characteristics of their operation, cater primarily to residents of neighborhood market areas. The C-1 Zoning District PMC 23.33.040 (15) specifically includes dance studios as a use permitted subject to obtaining a Use Permit

Subject Site and Surrounding Land Uses

The proposed dance studio is located on a developed commercial site between W. Bastanchury Rd. and N. Placentia Ave. The chart below shows surrounding existing land uses, zones, and General Plan Land Use Designations:

ZONING COMPLIANCE ANALYSIS

Site Development Standards

The project is located within the C-1 Zoning District. Pursuant to PMC 23.78.030, the code requires four (4) off-street parking spaces per one thousand (1,000) gross square feet. Sierra Vista Plaza Shopping Center, which consists of 100,500-square feet of retail space requires 402 parking spaces and provides 426 stalls. The proposed 1,078-square foot tenant space requires 4.9 spaces, which was included in the overall parking calculations for Sierra Vista Plaza Shopping Center. The Shopping Center has an excess of 24 parking spaces. The applicant’s proposal to expand the dance company’s business operations to include the 1,078-square foot space, will not add to the number of students the dance company has, but rather offer more space for private one-on-one lessons. This will not necessarily add to the number of vehicles in the parking lot. In addition, many of the students are dropped off by parents and do not utilize parking spaces. Based on staff’s analysis, the project meets all minimum and maximum development standards of the PMC, including minimum off-street parking requirements. The proposal meets the minimum number of off-street parking spaces required. No changes to the building footprint and overall building envelope will occur as a result of the project.

Other Departments Concerns and Requirements

The Divisions of Planning and Building, as well as the Department of Placentia Fire & Life Safety have reviewed the application, with no major concerns raised with the project proposal. The Planning Division identified comments and applicable code requirements that have been incorporated as conditions of approval into a draft resolution for consideration by the Planning Commission (Attachment No. 1).

ISSUES ANALYSIS:

General Plan Consistency

In an overall review of the General Plan, the proposed space to be used for the purpose of expanding the existing dance studio into another unit in the shopping center, for the purpose of offering a space for private lessons is consistent with the policies, programs, and goals of the General Plan. The General Plan Economic Development Element states in Goal 4, "Promote the revitalization of target areas and focus development to create vibrant destinations for the community." The Sierra Vista Shopping Center has struggled to keep tenant spaces occupied, therefore allowing a successful business, that already exists in the shopping center, to expand their business and utilize additional tenant space as proposed, helps to keep the vitality of the shopping center and possibly attract other businesses.

PMC Consistency

Adoption of the recommended conditions of approval will result in a project that complies with the provisions of the C-1 Zoning District. The proposed project, with incorporation of the recommended conditions of approval, will meet or exceed the requirements of the C-1 Zoning District and other applicable provisions of the PMC.

Land Use Compatibility

The project will be compatible with the land uses of the surrounding area because the proposed dance studio brings an additional service within an established commercial district containing primarily complementary commercial uses. The nature of the use will not have adverse impacts on adjacent business and properties as there are no significant noise or safety concerns.

CEQA:

The proposed application was reviewed by staff in accordance with the requirements of the California Environmental Quality Act ("CEQA"), Public Resources Code §§ 21000 *et seq.*, the State CEQA Guidelines, 14 C.C.R. §§ 15000 *et seq.*, and the Environmental Guidelines of the City of Placentia. Staff recommends that the Planning Commission exercise its independent judgment and find that UP 2023-09 is exempt from CEQA pursuant to State CEQA Guidelines § 15301 Class 1-Existing Facilities as it applies to the operation, repair, leasing or minor alteration of existing public or private structures, of facilities or features involving "negligible or no expansion of use".

PUBLIC NOTIFICATION:

Legal notice was published in the Placentia News Times on September 27, 2023, and legal notices were sent to property owners of record within a 300-foot radius of the subject property, and posted at the Civic Center on September 27, 2023, pursuant to all applicable provisions of the PMC. As of October 5, 2023, staff has received no comments in support of or opposition of the request.

CONCLUSION:

The proposed project is consistent with the City's General Plan and meets the minimum development standards of the PMC. With the recommended conditions of approval, the proposed establishment and operation of a dance studio, which will work in conjunction with an existing dance school within Sierra Vista Plaza Shopping Center, as additional space for private dance lessons, will be compatible with adjacent land uses and will not result in any significant or adverse impacts to the surrounding area.

RECOMMENDATION:

The Planning Division recommends that the Planning Commission of the City of Placentia adopt Resolution PC-2023-15 recommending approval of UP 2023-09 and finding that it is exempt from further CEQA review pursuant to Section 15301 of the State CEQA Guidelines.

RESOLUTION NO. PC-2023-15

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF PLACENTIA APPROVING USE PERMIT NO. UP 2023-09 AND MAKING FINDINGS TO PERMIT UP 2023-09 ALLOWING THE ESTABLISHMENT AND OPERATION OF A 1,078-SQUARE FOOT DANCE STUDIO, WHICH WILL EXPAND THE BUSINESS OPERATIONS OF THE APPLICANT'S PRIMARY DANCE COMPANY, WHICH IS LOCATED WITHIN THE SAME MULTITENANT COMMERCIAL SHOPPING CENTER WITHIN THE NEIGHBORHOOD COMMERCIAL (C-1) ZONING DISTRICT AT 1864 N. PLACENTIA; AND MAKING FINDINGS THAT THE PROJECT IS CATEGORICALLY EXEMPT PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) SET FORTH IN TITLE 14 CCR § 15301 (CLASS 1 – EXISTING FACILITIES) AND THE CITY OF PLACENTIA ENVIRONMENTAL GUIDELINES.

A. Recitals.

WHEREAS Lisa Silva representing “The Art of Dance and Ballet Academy” (“Applicant” hereinafter), located at 1864 N. Placentia Avenue, filed an application for approval of Use Permit No. UP 2023-09, as described in the title of this Resolution. Hereinafter, in this Resolution, the subject Use Permit request is referred to as the “Application”.

WHEREAS, on October 10, 2023, the Planning Commission conducted a duly noticed public hearing, as required by law, and after careful consideration of all pertinent testimony and the staff report offered in the case, the Planning Commission voted to approve UP 2023-09; and

WHEREAS all legal prerequisites to the adoption of this Resolution have occurred.

B. Resolution.

NOW, THEREFORE, it is hereby found, determined, and resolved by the Planning Commission of the City of Placentia as follows:

Section No. 1: Based on the evidence presented and the findings set forth, UP 2023-09 is hereby found to be consistent with the Placentia General Plan and the implementation thereof.

Section No. 2: Based upon the evidence presented to this Commission during the public hearing conducted with regard to the Application, including written staff reports, verbal testimony and development plans, this Commission hereby specifically finds as follows:

- a. The proposed request for the establishment and operation of a 1,078-square foot dance studio will not be: (1) detrimental to the health, safety, or general welfare of the persons residing or working within the neighborhood of the proposed use or within the city, or (2) injurious to the property or improvements within the neighborhood or within the City. The applicant has had an existing business for nearly fourteen years within the City of Placentia and is an integral part of the community. The business is rooted in providing artistic and athletic dance to young people, and also providing a safe place to practice, therefore this use is not detrimental to the health, safety, or general welfare of persons in the city. The applicant has never had any complaints about their business operations, and this Use Permit is an expansion of the existing business, therefore there is the determination of city staff that the business will not have any problems in regard to the injurious of property or neighborhood improvements. Subject to compliance with the attached Conditions of Approval and Standard Development Requirements (Attachment "A"), this use complies with all applicable code requirements and development standards of the Neighborhood Commercial Zoning District. Planning Staff finds that the intended use is in line with the intention of the Neighborhood Commercial Zoning District. Furthermore, (3) it is not anticipated that the additional tenant space, which is a separate additional space on the same property as the existing dance school, will generate any negative impacts onto adjacent properties and businesses. All primary activities shall be conducted within the enclosed building while maintaining an environment free from objectionable noise, odor, or other nuisances, subject to compliance with the attached Special Conditions of Approval and Standard Development Requirements. Moreover, the school will make use of existing parking, which is located in the primary parking lot and those on the easterly side of property.
- b. The proposed request for the establishment and operation of a 1,078-square foot dance studio, which will expand the business operations of the applicant's primary dance company is consistent with the City's General Plan. The General Plan Land Use designation for the subject site is Commercial. The business activities are commercial in nature and similar to onsite uses as the Crunch Gymnasium, which has similar instructional operations, including the existing dance company.
- c. The proposed request for the establishment and operation of a 1,078-square foot dance studio, which will expand the business operations of the applicant's primary dance company, which is subject to the attached Conditions of Approval and Standard Development Requirements (Attachment "A"), is consistent with the provisions of the Zoning Ordinance, or regulations applicable to the property. The proposed request for the establishment and operation of a dance studio is a conditionally-permitted

use in the Neighborhood Commercial (C-1) Zoning District. Approval of the Use Permit for the proposed dance studio will be consistent with the zoning, as the site can accommodate the use, and other similar uses, including the primary dance school owned and operated by the applicant, have been conditionally permitted within other similar commercial districts and within the same Neighborhood Commercial Zoning District.

- d. Conditions necessary to secure the purposes of this section, including guarantees and evidence of compliance with conditions are made part of the Use Permit approval process. Attachment “A” contains Conditions of Approval and Standard Development Requirements specific to UP 2023-09 to ensure compliance with the Placentia Municipal Code (PMC).

Section No. 3: Based upon the environmental review of the project, the Planning Commission finds that UP 2023-09 is exempt from the California Environmental Quality Act (“CEQA”), Public Resources Code §§ 21000 *et seq.*, the State CEQA Guidelines, 14 C.C.R. §§ 15000 *et seq.*, and the Environmental Guidelines of the City of Placentia pursuant to the State CEQA Guidelines § 15301 (Class 1 – Existing Facilities) as the permit would be issued to an existing structure or facility, and no expansion of the use is contemplated beyond the existing footprint of the building.

Section No. 4: The Planning Commission hereby directs that, upon approval of UP 2023-09, a Notice of Exemption shall be filed with the Orange County Clerk/Recorder.

Section No. 5: Based upon the findings and conclusions set forth herein, this Planning Commission hereby approves UP 2023-09, subject to the Conditions of approval contained in Attachment A hereto.

Section No. 6: The Secretary to the Planning Commission shall:

- A. Certify to the adoption of this Resolution; and
- B. Forthwith transmit a copy of this Resolution to the Applicant at the address of record set forth in the Application.

SPECIAL CONDITIONS

If the above referenced application is approved, applicant and/or property owner shall comply with the Special Conditions listed below and the Standard Development Requirements attached.

ALL OF THE FOLLOWING SPECIAL CONDITIONS OF APPROVAL AND STANDARD DEVELOPMENT REQUIREMENTS SHALL BE FULLY COMPLIED WITH TO CONTINUE IN GOOD STANDING TO PERMIT THE USE PERMIT TO ALLOW THE ESTABLISHMENT AND OPERATION OF A DANCE STUDIO, ON PROPERTY LOCATED AT 1864 N. PLACENTIA AVENUE.

DEVELOPMENT SERVICES DEPARTMENT – PLANNING DIVISION:

1. Use Permit No. UP 2023-09 is valid for a period of one (1) year from the date of final determination. If the use approved by this action is not established within such a period of time, this approval shall be terminated and shall be null and void, unless an extension is applied for and approved by the Director of Development Services.
2. UP 2023-09 shall expire and be of no further force or effect if the use is discontinued or abandoned for a period of one (1) year.
3. Failure to abide by and faithfully comply with any and all conditions attached to this action shall constitute grounds for revocation of said action by the City of Placentia Planning Commission.
4. The applicant shall, as a condition of approval, at its sole expense, defend, indemnify and hold harmless the City, its officers, employees, agents and consultants from any claim, action, proceeding, liability or judgment against the City, its officers, employees, agents and/or consultants, which action seeks to set aside, void, annul or otherwise challenge any approval by the City Council, Planning Commission, or other City decision-making body or City staff action concerning applicant's project. The applicant shall pay the City's defense costs, including attorney fees and all other litigation-related expenses, and shall reimburse the City for any and all court costs, which the City may be required to pay as a result of such defense. The applicant shall further pay any adverse financial award which may be issued against the City including but not limited to any award of attorney fees to a party challenging such project approval. The City shall retain the right to select its counsel of choice in any action referred to herein. The City agrees to promptly notify the applicant of any such claim filed against the City and to fully cooperate in the defense of any such action.

5. Any changes or modifications to UP 2023-09, or to the shall be subject to review and approval by the Director of Development Services or designee, with substantial changes or modifications subject to Planning Commission review and approval.
6. The two locations associated with the dance company under the permits UP 2023-09 and UP 2022-02 (1840 N. Placentia Avenue) are two separate and autonomous entitlements that shall not have any conditions of approval combined with or attached to the other. If one location ever closes, the other can exist, while following location-specific conditions of approval.
7. Any modifications to the approved floor plan or changes to the business operation hours, which do not expand or intensify the present use, shall be reviewed by the Director of Development Services, and may be modified administratively. Modifications may be brought to the Planning Commission for modification at the discretion of the Director of Development Services.
8. If at any time in the future, the Director of Development Services determines that a parking/circulation study is necessary to address parking and/or circulation issues relative to the use, the applicant, current business owner, and/or property owner, shall be responsible for the cost of a parking and/or circulation study prepared by a consultant selected by the City. The applicant, current business owner, and/or property owner shall also be responsible for the implementation costs of any mitigation measures deemed appropriate by the City based upon the findings of this study.
9. The applicant, current business owner, and/or property owner shall be responsible for maintaining the property, including the landscaped areas, walkways, and all paved surfaces, free from graffiti, debris and litter. Graffiti shall be removed by the applicant, current business owner, and/or property owner within 48 hours of defacement and/or upon notification by the City. The paint utilized to cover the graffiti must substantially match the existing structure. In the event that the paint finish of the abated area is noticeably distinguishable from the rest of the structure, the property owner shall paint additional portions of the building to minimize the disparity, subject to the approval of the Director of Development Services.
10. The applicant, current business owner, and/or property owner shall obtain approval of a Building and Zoning Compliance Application and shall obtain approval of a city business license. The applicant, current business owner, and/or property owner shall always maintain a valid city business license during operation of the business. This location will need a business license independent of the primary location.
11. This UP may be periodically reviewed at the discretion of the Director of Development Services in order to determine if the business is operating in compliance with all required Special Conditions of Approval and Standard Development Requirements.

12. There shall be no special promotional events held on the property, unless a written request for such is received and approved by the City of Placentia Development Services Director and the Police Department's Administrative Lieutenant at least 14 days prior to the scheduled event.
13. The use shall comply with the following:
 - a. Prior to any changes to the days and hours of operation, the applicant shall obtain written approval from the Director of Development Services or his/her designee. The following are the specified days and hours of operation:

Monday through Friday: 10:00AM – 9:00PM

Saturday through Sunday: 9:00AM – 5:00PM
 - b. All doors shall be shut during normal business hours to avoid free unrestricted access into the facility.
 - c. Drop off and pick up of students shall not occur from idling vehicles within the drive aisles. Vehicles are required to park within a designated parking space and walk students into the facility.
 - d. No vending machines of any kind shall be installed outdoors within the project site.
 - e. No outside storage within the parking lot area shall be permitted at any time.
 - f. The use shall comply with all provisions of the PMC, including Chapter 23.76 Noise Control.

DEVELOPMENT SERVICES DEPARTMENT: BUILDING DIVISION:

14. Shall provide complete architectural, structural, electrical, mechanical, and plumbing plans, which are prepared sealed and signed by a California licensed architect or civil/structural engineer. The E/M/P plans could be prepared sealed and signed by the architect or engineer of record or California licensed electrical and mechanical engineers or alternately by the California licensed electrical and mechanical contractors who are performing the jobs.
15. The required plans shall comply with the City adopted and amended 2022 California Building, Electrical, Mechanical, Plumbing, Title 24 California Energy, and Green Building Standards Codes.
16. Architectural plans shall address the plans of the existing and the new floor areas and the site within the vicinity of the (N) space.
17. Shall address on plans complete applicable accessibility items per 2022 CBC Sec. 11B-202.3 Alterations.

18. Electrical, mechanical/plumbing engineers shall prepare, seal, and sign the required electrical, mechanical/plumbing plans of the existing and the new ones per the architectural plans requirements. California licensed contractors who are performing the Electrical, Mechanical, and Plumbing jobs may prepare the corresponding plans, sign and write their license class and No. below their signatures.
19. On the first sheet of plans shall provide a complete scope of all works to be performed under the required permit application.
20. On the first sheet of plans shall address complete project data, which should include but not limited to Group Occupancy, Type of Construction, Occupant Load, Fire Sprinkled or not.
21. The proposed dance studio walls adjacent to other spaces shall be addressed to be one-hour fire resistance construction from floor concrete slab to roof sheathing.
22. A California licensed architect or engineer shall oversee the plan design, as well as their preparation.



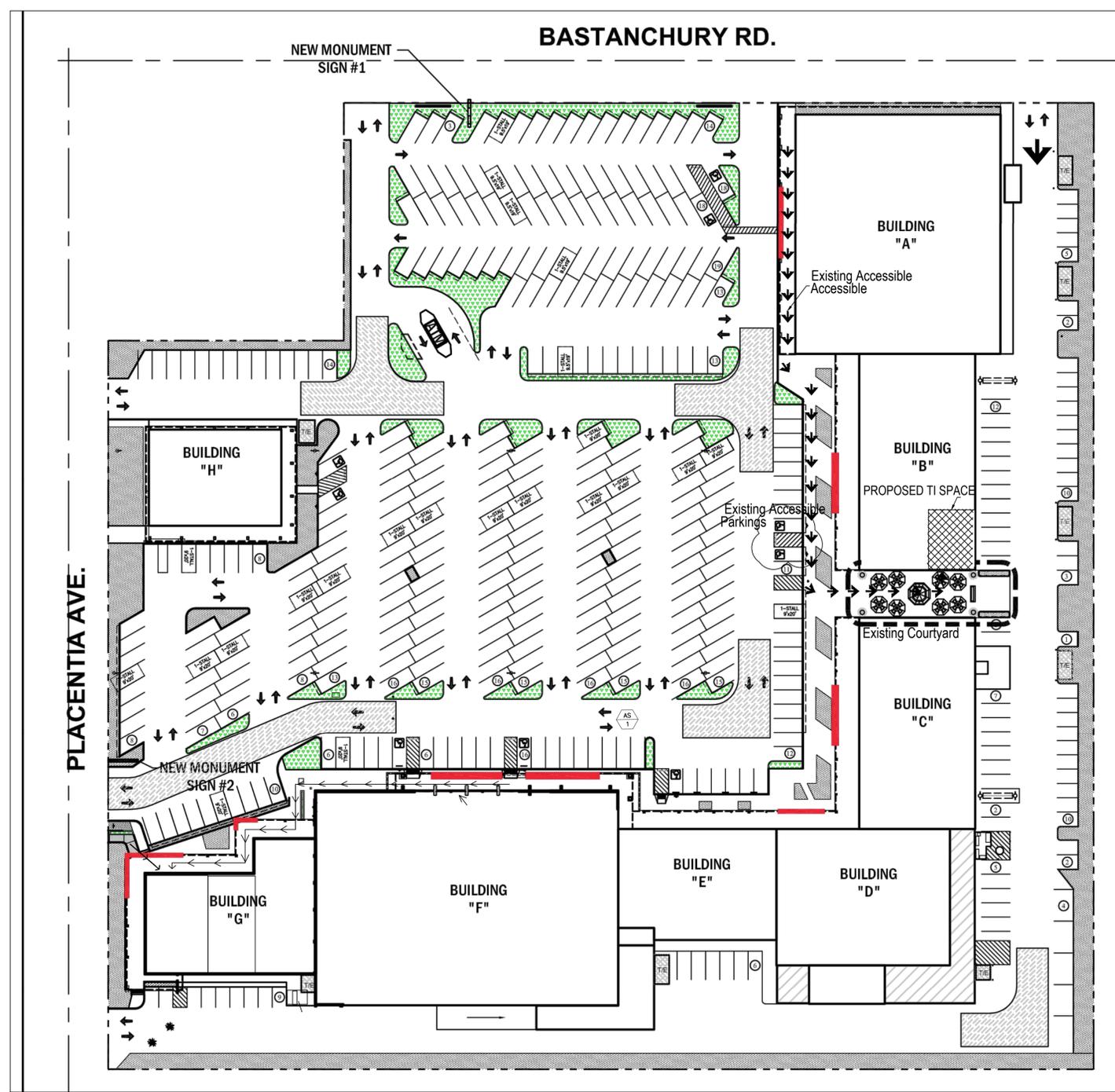


Figure 2 Looking North at Subject Site
