If costs exceed he deposit amount, an addition deposit(s) will be required.

^B If a City Councilmember brings an appeal, no fee is charged.

^C Plus inspection fee, if necessary.

^D Permit required, but no fee charged.

^E Plus any costs from other departments

^F First-time registration permit fee.

^G Renewal fee for existing businesses that have already registered with the City will be 75% of the initial registration permit fee. This reduced renewal fee will apply only to the same calendar year of the first-time registration date.
