

## RESOLUTION NO. R-2020-73

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLACENTIA, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 3, 2020, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

#### A. Recitals.

(i). A General Municipal Election ("Election") was held and conducted in the City of Placentia, California, on Tuesday, November 3, 2020, as required by law.

(ii). Notice of the Election was given in the time, form and manner as provided by law; voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Code of the State of California for the holding of elections in general law cities and pursuant to the requirements of the Placentia City Charter.

(iii). The Orange County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached, and made a part hereof as "Exhibit A".

(iv). All legal prerequisites to the adoption of this Resolution have occurred.

#### B. Resolution.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PLACENTIA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

1. In all respects as set forth in the Recitals, Part A., above.
2. The whole number of ballots cast in the precincts except vote by mail voter ballots and provisional ballots, was 4,985.
3. The whole number of vote by mail voter ballots cast in the City was 21,719, making a total of 26,704 ballots cast in the City.
4. The names of persons voted for at the election for Member of the City Council, District 1 are as follows:

8. The number of votes given in the City to each of the persons above named for the respective offices for which the persons were as listed in "Exhibit A" attached hereto and by this reference made a part hereof.

9. The City Council does declare and determine that:

Rhonda Shader was elected as Member of the City Council, District 1 for the full term of four (4) years;

Jeremy B. Yamaguchi was elected as Member of the City Council, District 3 for the full term of four (4) years;

Ward L. Smith was elected as Member of the City Council, District 5 for the full term of four (4) years;

Robert S. McKinnell was elected as City Clerk for the short term of two (2) years; and

Kevin A. Larson was elected as the City Clerk for the full term of four (4) years.

10. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the Election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; and (4) The total of number of votes given to each person.

11. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the Office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

12. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
