I. APPLICATION INSTRUCTIONS

A. INTRODUCTION

The County of Orange has notified the City of Placentia that they will receive a formula allocation of funding by the Coronavirus Aid, Relief, and Economic Security (CARES) through the County's Community Development Block Grant Funds (CDBG-CV3) to be used specifically for small businesses in Placentia that have been directly impacted by the COVID-19 pandemic. On September 7, 2021 the Placentia City Council approved the allocation of these funds. The City of Placentia is accepting applications from businesses that meet the following requirements:

- Small businesses and non-profits must have no more than 25 employees (FTE)
- Home based businesses are eligible (home mortgage, vehicle payments, or owner's salary are not permissible expenses)
- Independent contractors and sole proprietors are eligible, however, funds cannot be used for salary, lost profit, or lost income
- Main place of business must be in Placentia
- Applicant must have and provide a DUNS number at time of application
- Applicant must be willing to attest to a statement verifying that the award was used for costs necessary due to impacts associated with COVID-19
- Applicant must be willing to attest to a statement verifying there are in compliance with all local, state and federal Covid-19 guidelines and orders.
- Funds can't be used for tax revenue replacement, to pay for loans or overtime
- Must be open and in operation for at least twelve (12) months
- Must not have any existing municipal code violation(s)

B. AVAILABLE FUNDING

The program is based on the availability of County funds, program guidelines, and submission of all required information. Based on the criteria stated above, eligible

applicants will receive a working capital grant of up to five thousand dollars (**\$5,000**) to support payroll expenses, rent, utility expenses, employee salaries or similar expenses that occur in the ordinary course of business from March 27, 2020 to May 31, 2022. According to the County’s allocation, the City would be able to assist approximately eighty-one (81) small businesses within the City of Placentia.

D. APPLICATION GUIDELINES

1. Maximum Grant Request: **\$5,000** for expenses that occur from March 27, 2020 to May 31, 2022.
2. All applications must follow the formatting described below or be subject to penalty points:
 - a. Only one application per business will be accepted;
 - b. Required documents must be attached to this application;
 - c. The completed and signed application including any and all supporting documentation must be emailed to Jeannette Ortega, Assistant to the City Administrator at jortega@placentia.org or via address at 401 E. Chapman Avenue, Placentia, CA 92870.
3. List of Ineligible Applicants
 - a. Any activity that is not directly related to the COVID-19 pandemic
 - b. Reimbursement for expenses that have been accrued prior to March 27, 2020
 - c. Expenses currently paid for by other funding sources
 - d. Political activities and lobbying

F. REVIEW PROCESS AND SCORING

1. Review Process

The Grant Review Committee will review and score all applications based on the scoring categories. Staff will prepare a list of the rated applications from highest score to lowest score, including the Committee’s recommendation, this will be given to the City Administrator for review and approval.

A program timeline for the review process is below but subject to change:

September 8, 2021	Applications are available
October 4, 2021	Applications DUE by 5:00 p.m.
October 5-7, 2021	Committee reviews and scores all applications
October 11, 2021	Committee recommends funding allocations to City Administrator
October 14, 2021	Funds are distributed to qualifying businesses

2. Scoring Categories

Applications will be rated and ranked on the basis of their responses to the application elements.

1. Business Description.....20 points
2. Estimated Adverse Economic Impact.....20 points
3. Need for Funds.....20 points
4. Sales Tax Generation20 points
5. Documentation.....20 points

G. RESERVATION OF RIGHTS

The City of Placentia reserves the right, at its sole discretion, to award all, a portion, or none of the available County funding, and may reject any and all applications based on the quality and/or merits of the application, or when it is determined to be in the public interest to do so. Furthermore, the City may extend deadlines and timeframes, as needed.

The City of Placentia reserves the right to substantiate any applicant's qualifications, financial information, capability to perform and availability.

The City of Placentia reserves the right to waive any informalities in application, to accept any application or portion thereof, and, to reject any and all applications, should it be in the best interest of the City to do so.

H. POST AWARD AND SUB-RECIPIENT CRITERIA

All awards are subject to the City's receipt of its funding appropriation from the County of Orange. The City of Placentia is committed to monitoring the performance of grant recipients to ensure that all funds are used appropriately.

Businesses that have been awarded the grant must remain operational for a period of three months after receipt of funds. If a business closes during the three-month period after receipt of funds, the business must pay back the grant amount to the City of Placentia within 30 days of the business closing.
